

The role of Secretary and Careers Officer comprises of two overall responsibilities: those that fall under the category of being 'Secretary', and those that fall under the category of being a 'Careers Officer'.

The responsibilities of a Secretary are that which fall under the title of 'core committee'. This means you form part of the central four roles that the SU require each committee to have. Being in such a role requires you to oversee almost everything that happens within the society. Specific responsibilities of the Secretary include:



- Arranging committee meetings
- Communicating with fellow committee members to formulate the agenda for each committee meeting
- Taking the minutes for each committee meeting
- Room bookings, External Speaker Forms, and Trip Registration Forms (in collaboration with the Health, Safety and Communications Officer)
- Organising the AGM alongside the President
- Communicating with the SU the Secretary is the point of contact between the SU and other Committee members.
- Support the Committee in any way you can
- Other administrative responsibilities e.g. placing products on the UPSU site and emailing members with updates from the society.

The nature of the work of the Secretary means that you rely heavily on other committee members. The SU and the society have strict deadlines, and it is the responsibility of the Secretary to ensure these deadlines are met. The role of the Secretary requires an organised individuals who has a passion for the society and a drive to get all the jobs done.

The Careers Officer aspect of the role includes:

- Organising careers events including communicating with professionals to organise these events
- Sending out the 'save the date' invitations, formal invitations, and reminder emails to professionals attending our Annual Cheese and Wine Networking Evening.

The role of Secretary and Careers Officer really is what you make of it. I recommend that any individual who is organised, interested in increasing their IT and networking skills, and has a passion for the UPLS, should apply for this role!



TREASURER

Treasurer is one of the 'core' committee roles in the UPLS. Being Treasurer for the UPLS will provide you with such important skills as teams working, time management, organisation and networking that are so important in the legal industry:

During this role you will be responsible for a number of things including:

- Creating a sponsorship package, as a PDF document in the beginning of the academic
- Researching potential sponsors (usually local law firms and other legal organisations)
- · Reaching out to them and therefore, networking
- Managing payments
- Keeping track of expenses
- Reviewing and approving budget of the UPLS for the first and second semesters
- Applying for funding from the UPSU twice a year
- Keeping contact with the sponsors
- Organising events with the sponsors if necessary

The role of the Health, Safety and Communication Officer, is divided into two roles. As part of the *health and safety role*, I am in charge in creating risk assessments for any event or activity which the society wishes to conduct. Don't worry if you've never done a risk assessment before, the SU will provide you with a template and also organise a session which helps you to know what to look for when completing the risk assessment. You will have to keep in contact with the other members of the committee constantly to know what events or activities they are planning to do throughout the year so that you can cover as much as possible when you fill out the general risk assessment at the start of the year.



It is also advised for you to be first aid trained. This is because when there is an event there will need to be a first aider on sight just in case! But do not worry, you will be given a chance to complete the course to be qualified! (This will also look good on your CV).

As part of the communication role, you will be in charge of all of our social media accounts.

I would advise anyone interested in this role to follow all of the accounts to have an idea of what type of posts are expected of you! And if you enjoy being creative, this is the role for you!!

It is important for you to communicate with the other committee members. This is because you need to know what you need to advertise with enough time for members to check their schedules. Also, if you need any committee member to do anything, put some strict deadlines in place and keep on top of them so that you do not fall behind your own.

Most importantly, you will have to create the UPLS newsletter 3 times during the academic year. I will provide you with the original template which was used last year. DEBATING OFFICERS

Being a Debating Officer for the UPLS will provide you with skills essential for an impressive CV, such as responsibility, teamwork and organisation, whilst helping you expand your legal networking when collaborating with legal professionals to judge.

During this role, you will be responsible, alongside a fellow Debating Officer, for a number of tasks throughout the academic year including:

- Promoting participation in the Debate Competition at Freshers fairs.
- Preparing a workshop before the rounds begin to help interested parties to understand the nature and structure of the debates.
- Organising and preparing five rounds of debates.
- Setting propositions that are interesting but not too complicated to debate.
- Keeping in contact with the participants to ensure they receive the required information for each round of debate.
- Contacting professionals within the legal sector to judge the semifinal and final rounds.
- Providing feedback forms to the participants after each round.

As part of the committee itself, you will also attend meetings where you will discuss any upcoming rounds and activities that you are interested in running, and as one of two Debating Officers, you will be required to stay in contact with your partner to ensure a balanced workload between the two of you and cooperation about the competition.

For the next academic year, you will also be in charge of the Mock Trial Competition. This is normally part of the Events and Activities Officers role, but after this year, we feel though as it would be better for our Debating Officers to do so. The Events Officers normally run the competition late February/March, with two local magistrates. But do not worry, when the handover happens, the Events Officers will explain a bit more.

We must say that being a negotiation officer is a very enjoyable role, and we are both very happy for applying last year for it. The Negotiations Competition is a very fun and relaxing competition without any law needed. It is a great way to meet new people from all three years, making friends, talking with professionals as we cooperate with Womble Bond Dickinson and GA Solicitors law firms as well as closely with lectures.



The main tasks that a Negotiation Officer has to do is to write some scenarios with their partner on different topics such as tenancy, contract, venues etc and will also judge their participants and schedule the day or days you will hold its rounds.

The number of rounds is left at your discretion and usually, the last two rounds are given to lecturers and professionals to write a scenario and judge them. It is something that you can put on your CV and law firms are generally interested. You can also improve some of your skills, such as communications, critical thinking, organisation, and time management as you have to balance them with your studies. We strongly urge you to apply for this role.

In addition to the Negotiations Competition, the next academic year you will be expected to run and organise the Client Interviewing competition. This is usually conducted by the Events Officers, however we have decided that it would better suited for this role. The competition is done with the help of Wolferstans Solicitors. Running 5 rounds and the talk was logistically challenging, but we have been told by the Events Officers that they felt that people have learnt a lot.
